
**NOTICE INVITING TENDER**

Sealed tenders are invited in two bid systems (Technical and Financial bid) from the intending registered firms/ Regd. NGOs/Regd. Organizations /Regd. Manpower service providers/Contractors desiring for cleaning and sanitation work from ward No. 01 to 09 of Paralakhemundi Municipality which includes road sweeping, cleaning of drains, bush cutting, Lifting of dead animals and door to door collection of Solid waste in Segregated manner and lifting of garbage to concern MCC & MRF centers of Paralakhemundi Municipality within 5 K.M lead by engaging 3 (Three) numbers of tractors with drivers.

The tenders shall be prepared and submitted separately in sealed envelopes in two parts, Part I and Part II clearly indicating on the cover Part-I (Technical bid) and Part-2 (Financial Bid).
