Eligible criteria for Selection of MSGs.

- a. MSG Must be from the same ward or adjacent ward.
- b. MSG Must be registered with housing & Urban Development Department/Mission Shakti and following Panchasutra.
- c. MSG Must be at least one –year-old as on date of notification of EOI.
- d. MSG Must have an active bank account.
- e. MSG Must have a PAN Card in the name of their group.
- f. MSG must not have defaulted repayment to any loan availed from bank or non-bank financial institution (NBFI).
- g. Selection of MSG will be based on Amo Pokhari SOP.

Any other criteria may be placed by the appreciate authority.
