Eligible criteria for Selection of SHGs.

- a. SHGs register with NULM or any other promoter is eligible for participation.
- b. Date of formation of group shall be minimum 3years prior to the date of submission of application
- c. SHGs must be following Strictly adhering to Pancha Sutra.
- d. Must have involved in Income Generating Activities(Minimum criteria last 3years).
- e. SHGs mustTurnover of at least 2lakhs in one financial year within past three years.
- f. No financial irregularities.
- g. No record of involvement in any anti-social or criminal activities.
- h. At least one memberof the group should have basic education till 8th standard and digitally literate.
- i. Preference to be given to SHGs from the same ward.In case of non-availability of eligible SHGs within the Ward area,application may be invited from other wards.

Any other criteria may be placed by the appreciate authority.
